1. Edward Said: Said defines identity as a collection of cultural experiences and interactions that shape an individual's sense of belonging. He emphasizes the importance of social and political context in shaping identity, noting that it is not fixed but rather fluid and contingent upon historical circumstances (Said, E. W. (1978), pp. 322-325).



- 2. Stuart Hall: Hall defines identity as "a process through which the self is understood in relation to social and cultural relationships." He points out that identity is not merely a personal matter but is intertwined with cultural and political contexts that intersect with individual experiences (Hall, S. (1990), pp. 222-237).

He indicates that identity reflects the diversity and complexity of different social contexts, making it a dynamic element influenced by social changes (Giddens, A. (1991), pp. 52-60).
